Making progress one state – and many kids – at a time

- Florida has a brand-new requirement that all high school students take a stand-alone personal finance course before graduation – this benefits ~220,000 kids each year!
- Michigan also has a brand-new stand-alone personal finance course requirement for high school graduation – benefitting ~115,000 kids each year!
- The Kansas State Board of Education voted to make personal finance a graduation requirement beginning in 2027.
- CEE helped conceive and draft legislation for the state of Pennsylvania, which passed the State Senate in a bipartisan vote.
 We have high hopes that in this legislative session, it will be passed in both the State Senate and House and be signed into law!

Building support in PA

On a fall day in September, CEE, VISA and the NFL joined forces in Harrisburg Pennsylvania to build support for personal finance education requirements. In a well-attended and spirited event, we heard from legislators and advocates who educated and informed and enjoyed watching Brandon Copeland, Hines Ward, and Brian Dawkins play some football with PA high school students – Financial Football, that is!







FROM THE CHAIR



Last year American households faced once-ina-lifetime economic and financial challenges. Inflation reached its highest level in more than four decades; borrowing costs surged as the Federal Reserve was forced to aggressively tighten monetary policy, and savings eroded as both US equity and bond markets lost money for only the third time since 1926.

Navigating this environment required an understanding of economics and personal finance that remains lacking for much of the country's population. Surveys done in recent years reach a similar conclusion: that the majority of US adults do not have the knowledge or tools to make wise financial decisions, with the need generally greater among women and lower-income communities.

This has to change, and we need to start early. If we want a strong economy in the decades to come and financially healthy families, we need more states to adopt high school graduation requirements in economics and personal finance. CEE, in addition to training teachers and working directly with students and families, is determined to get K-12 economic and financial education to all 50 states. As I look ahead to my second year as CEE's Board Chair, I'm excited for the progress we will make in 2023, thanks in large part to all of your continued support.

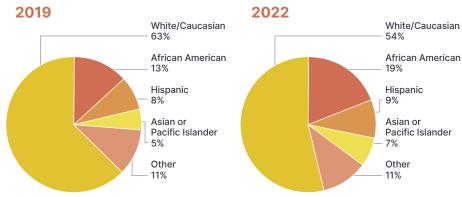






National Personal Finance Challenge – Rebounding after the pandemic & making strides in diversity!
