Each year, close to 10,000 students from across the nation take the chance to shine while being tested on key micro and macroeconomic principles, as well as their knowledge of the world economy.


The National Economics Challenge provides a platform for high school students of economics to compete with their peers on a national scale and make themselves and their schools proud.



Nan J. Morrison is president and chief executive officer of the Council for Economic Education. She has overall responsibility for deepening and expanding CEE's work to deliver on its mission, including working closely with CEE's 200 affiliates across the country. This role marries her passion for giving kids the tools and confidence to achieve their dreams with her experience in the business world, keeping CEE's mission relevant and leadership in the field strong.

Prior to joining CEE, Nan was a partner at Accenture, working with senior leaders at several major universities and the NYC Department of Education. She was also a partner at the Boston Consulting Group, Mercer Management Consulting. Additionally, Nan has held operational roles at Morgan Stanley and General Electric.

Nan serves on the Advisory Board of the MIT Center for Finance and Policy and CNBC's Financial Wellness Advisory Council. #### **Emcee: Steve Liesman, CNBC Senior Economics Reporter**



As CNBC's senior economics reporter, Steve Liesman reports on all aspects of the economy, including the Federal Reserve and major economic indicators. He appears on "Squawk Box" (M-F, 6AM-9AM ET), as well as other CNBC programs throughout the business day.

Liesman joined CNBC from The Wall Street Journal where he served as a senior economics reporter covering monetary policy, international economics, academic research and productivity. At the Journal, Liesman previously worked as an energy reporter, and Moscow bureau chief. He won an Emmy for his coverage of the financial crisis and was a member of the reporting team recognized with a Pulitzer Prize for stories chronicling the crash of the Russian financial markets.

Prior to joining the Journal in 1994, Liesman was the business editor for The Moscow Times, where, as the founding business editor for the country's first English-language daily newspaper, he helped create the publication's stock index, which was the country's first. Liesman also has worked as a business reporter for both the St. Petersburg Times in St. Petersburg, Fla., and The Sarasota Herald-Tribune in Sarasota, Fla.

Liesman holds an M.S. from Columbia University Graduate School of Journalism and a B.A. in English from the State University of New York, Buffalo.

**Dr. Julie Heath,** Executive Director Emerita, Alpaugh Family Economics Center University of Cincinnati

Prior to coming to UC, Dr. Heath spent 26 years at the University of Memphis. She received a Visiting Research Fellowship to Princeton University to conduct research in economics education and has published extensively in this area. She is the author or co-author of over 40 academic articles. She won an Emmy Award for her work on the SmartPath suite of resources that brings economics and financial education to young children. She was named a "Money Hero" by Money Magazine, a "Woman of Achievement" by the Girls Scouts of America, and a U.S. Professor of the Year in Tennessee by the Carnegie Foundation.



Matthew Gherman has been a New York City teacher since 2007, starting in James Madison High School and now working at Edward R. Murrow High School since 2010. He earned his Bachelor's and Master's at Brooklyn College. Since 2011, Matt teaches AP Macro Economics and College Now Business Administration. In 2015, Matt won the Council for Economic Education's Alfred P. Sloan Award and has collaborated with the Council as a Master Teacher since then; leading professional developments, webinars and judging the economics competitions. He is a contributing author for the Council for Economics Education 5th Edition AP Macroeconomics Teacher Guide and Student Workbook. Helping to coordinate the personal finance curriculum at Murrow, Matt has helped to extend the WISE Foundation Financial Literacy Certification Program throughout the whole senior grade. Murrow has earned recognition as a WISE "blue ribbon school," and Matt has earned several "WISE Gold Star Teacher" recognitions. Working with the Junior Achievement Program, he trains senior students to teach personal finance to elementary school students. Matt believes that making students financially literate embodies the Murrow philosophy of "life ready, career ready and college ready."



**Alex Lamon** is the Lead Teacher for Business Education at Livingston High School, NJ, and the Executive Director for the New Jersey Council for Economic Education. Alex currently teachers Advanced Placement Economics, Investing and Personal Finance. He was recently published in the Council for Economic Education's AP Macroeconomics Teacher Manual and Student Workbook. **Seth Carpenter** is a Managing Director and Chief Global Economist at Morgan Stanley. Previously, he was Chief US Economist for UBS and Head of US Research for Rokos Capital. During his 15 years at the Federal Reserve, he rose to the position of Deputy Director of the Division of Monetary Affairs, working on monetary policy strategy and implementation. At the US Treasury, he was Deputy Assistant Secretary for Macroeconomic Analysis and then was nominated by President Obama to be Assistant Secretary for Financial Markets. Seth earned his PhD in Economics from Princeton University.



**Rob Fauber** is President & Chief Executive Officer of Moody's and a member of the Board of Directors.

Rob's career spans nearly 35 years across business information, finance and risk, and he has served as Chief Executive Officer of Moody's since 2021. Over the course of Rob's 19 year career at Moody's, Rob has been integral to the growth and evolution of the company as Moody's has transformed into an industry leader in risk assessment and one of the fastest growing public companies in its sector. **Bruce Kasman** is a Managing Director and the Chief Economist for J.P. Morgan. He serves as Global Head of Economic Research, where he is responsible for leading a team of more than thirty economists worldwide that set the firm's economic and policy views. Mr. Kasman and his team integrate detailed country analysis with a top-down approach that views the global economy as a whole. J.P. Morgan's global economics team has consistently received high rankings in investor polls and has been ranked #1 in the Institutional Investor global fixed income poll for five consecutive years (2019-2023). Mr. Kasman joined J.P. Morgan in 1994 and was Head of European Economic Research from 1996 to 1999. Prior to J.P. Morgan, he was Senior International Economist at Morgan Stanley. Mr. Kasman started his career at the Federal Reserve Bank of New York in the International Research Department. He has a Ph.D. in Economics from Columbia University.



**Dean Maki** is the Chief Economist for Point72 based in Stamford, Connecticut. He joined the firm in 2015 and leads a team that is responsible for analyzing and forecasting the U.S., Asian, and European economies and monetary and fiscal policies.

Before joining Point72, Dean was Managing Director and Chief U.S. Economist at Barclays from 2005 to 2014. He previously worked as a Vice President of Economic Research at JPMorgan Chase, responsible for forecasts of Federal Reserve policy, the federal budget, and Treasury debt issuance. Earlier in his career, he worked as a U.S. economist at Putnam Investments and was a Senior Economist at the Federal Reserve Board, where his research focused on the relationship between household balance sheets and consumer spending.
